

Full Essay structure:

⇒ Introduction – Paraphrase + Thesis

The role of paying taxes has been a controversial issue, and some believe that by taxation, they are contributing sufficiently to their community. However, this is not an ideal view for others who argue that there are other more important responsibilities of citizens in addition to taxes. Both ideas seem to be rational in their own ways, but I do believe we should not be limited with only shouldering a tax.

⇒ MB 1 – First idea explored (some)

On the one hand, paying taxes could be big enough contribution to a community. In most countries, citizens are burdened with different rates of taxes, and when all these tax money is calculated, it can amount staggering figures, with which almost all areas of society can be improved and flourish. For example, an average individual's 35% of monthly income in Sweden is channeled to state budget as a

means of taxes. This means those people are already making <u>financial sacrifices through tax</u> system for <u>the betterment of their society</u>, which is why the idea of <u>taxes are significant contribution</u> can be justifiable.

⇒ MB 2 – Second idea explored (others + opinion)

Having said that, I believe paying taxes is one of the many responsibilities that we people have. For instance, in order to <u>raise money</u> for those who live in poverty, without a shelter or need financial assistance in their <u>late</u> ages, donations to charities are also a must. These are not <u>established by law obligatory</u>, yet <u>contribute a lot</u> for the well-fare of society. Environmental conservation is also another matter. Unless everyone is generally involved in Green Projects, such as Car-Free Days or Recycling, environmental problems may continue deteriorating. With only paying taxes, these sorts of issues may not be dealt with, so additional responsibility is required.



As there are increasingly more consumer goods <u>to</u> <u>be produced</u>, ecosystems around the globe <u>are</u> <u>damaged</u>.



A rise in consumer goods worldwide is due in large part to overpopulation. The demographic numbers have been escalating so far, and the year 2023 reported that the earth population exceeded 8 billion, a figure which is expected to continue further. As these individuals have basic necessities covered by consumer goods, the amount of production naturally increases. What makes this trend deleterious is that the more consumer goods are produced, the more carbon gases are emitted. In other words, in order to

meet increasing demand by rising population, factories accelerate their production processes, which leads to the release of greater amounts of greenhouse gases.

However severe this problem may seem, there are some feasible ways to address it. Undeniably, it is impossible to com
