Dear Mr. President Trump,

Pirates have hijacked and taken control of the Helm of the Ship of State here in Utah. Every branch of government is corrupted by these Pirates. They have used the corrupt courts to silence honest voices while installing their puppets in key state positions.

In Utah's corrupt political cesspool, conservative voters have suffered a vile betrayal. Shockingly, you've endorsed Rob Axson, Utah's current GOP Chair, who brazenly condones this rot. Axson backs Cox, heartlessly ignoring calls to investigate heinous election crimes against Utahns. Voters see these outrageous crimes as assaults on their civil rights, shattering Utah's electoral foundation. Let us explain:

- First, one glaring example is our current Governor Cox. He was eliminated as the Republican candidate through the State's primary convention process at the Utah Republican Primary Convention where elected delegates voted on April 27, 2024. Phil Lyman won the vote decisively with 67.54% in that statewide convention vote. Utah GOP party constitution and bylaws dictate if any candidate wins more than 60% of the delegate vote at convention, they are the nominee for the Republican Party of Utah on the general election ballot: there is no "second chance" primary to seek the party's nomination that lawfully exists. Phil Lyman was the Republican Party nominee period! Imagine, Mr. President, if after being nominated at the Republican National Convention (RNC), you were then forced by the RINO's of the party into an additional race to secure the Republican nomination before proceeding to the general election. What if the RINO's had succeeded in a totally fraudulent second vote and placed another candidate as the Nominee? Would you have accepted that?
- Second, Phil Lyman was unjustly forced to divert critical campaign funds, donated by his loyal supporters, to a fraudulent second primary election to defend the Republican nomination he had already won. This election, unsanctioned by state law or party rules, was illegally thrust upon Lyman compelling him to battle Cox again for the nomination instead of letting him focus on his Democratic opponent and costing months of his volunteer's campaign time and resources. In Utah, the absence of a Secretary of State leaves elections under the control of the lieutenant governor, Cox's handpicked running mate. This glaring conflict of interest, where the Governor's running mate oversees their own election, flings open the door to fraud. This allowed Cox full control through the Lt. Governor's office to manipulate the process, usurping the elected delegates vote and unlawfully declaring himself the Republican nominee.

In addition, a private company which conducts signature-gathering campaigns, was contracted by Governor Cox seeking 28,000 Utah registered voters which was the magic number needed to place Cox on a primary ballot. Eleven signature gatherers subsequently faced charges of forgery and related offenses for submitting invalid signatures during the 2024 primary election cycle. Months later an audit conducted by the Utah legislature confirmed that Cox failed to meet that 28,000 required signature threshold. By then irreversible, serious damage had already been done to Phil Lyman's campaign and no corrective action was taken which compounded the fraud when the Lt. Governor proceeded with Governor Cox as the Republican candidate. Although those involved have accepted plea deals, further criminal investigations into these matters both state and federal are required but are being stalled.

- Third, when Phil Lyman sought justice through the courts to challenge these unlawful actions, corrupt judges, unjustly dismissed his cases and the legislature continued to fail to act. The Republican Party, led by current Chair Rob Axson, is MIA concerning the election theft. Cox and Rob Axson are tag teaming their support for each other and mutually benefitting against the will of Utah voters. The only thing Cox was legally afforded was to run as an unaffiliated "write-in" candidate. Instead, Cox was placed unlawfully on the General Ballot by his Lt. Governor as the Republican nominee, a total falsehood. Phil Lyman was forced to run as the unaffiliated write-in candidate, an absolute reversal of what should have happened. Lyman fought incessantly, securing **200,551** votes in the general election, setting a national record for the most write-in votes in a non-presidential election. Despite this historic achievement, the corrupt system continues to obstruct his rightful claim to the nomination and the governor seat.

Mr. President, undeniable proof shows your 2020 election was stolen, and We the People know you'll fight back - justice is coming. Likewise, Utah's 2024 governorship was stolen through brazen fraud, and we won't stand for it. We demand state and federal GOP leaders, alongside the Department of Justice, join us to oust the lawless Pirates who have hijacked our ship of state - in line with your Executive Orders for electoral integrity. Axson, who is a complicit coward, did not demonstrate to be the fighter we deserve to protect our voice and earn our trust to lead Utah's GOP. Following the convention, Axson had every opportunity to demand that Utah election State law and the Utah Republican Party Constitution be followed and advance Phil Lyman directly to the general ballot as the Republican Candidate. Whoever is advising you on this matter in Utah, is either woefully complicit in the theft or conveniently ignorant of the facts.

Phil Lyman, our America First hero, has fearlessly fought these Pirates and has won in the court of public opinion. He's our true Republican candidate and your true MAGA ally, before and after he received your bold Presidential pardon. The operatives that Axson has aligned himself with have been unable to win honestly. They unabashedly continue to scheme, lie and defraud Utah's voters, trampling our civil rights.

We earnestly implore you, Mr. President, to see through the pirates' treachery - those working to tear down your America First Agenda. We ask that you support and endorse Phil Lyman for Republican Party Chair of Utah after withdrawing your ill-advised support for the spineless current party chair Rob Axson. Please help us fight to reclaim our state for the people before this Ship of State is lost forever.
