## Re: CEASE AND DESIST

Dear Mr. Sargent:

The undersigned is legal counsel to Paul Lindberg, Robbie Davidson, and Patricia Steere. The purpose of this letter is to officially DEMAND that you immediately Cease and Desist from making any further false, defamatory, or misleading statements about my clients that have caused significant harm to their reputation and professional standing; and that you issue a public retraction on the same forums where the defamatory statements were made.

To be clear, you have made numerous false, defamatory and misleading statements about all of my clients, including but not limited to:

- Alleging that my clients committed SEC violations related to Axion.
- Asserting that they lost large sums of money in Axion and were desperate for funds.
- Stating that they were pressured by authorities into renouncing Flat Earth beliefs in exchange for protection from legal consequences relating to the SEC.
- With respect to Patricia Steere, maintaining that she received a car in exchange for turning away from being an active member of the Flat Earth Community.
- Contending Robbie Davidson accepted thousands of dollars in order to allow Logan Paul and Jake Byrd (of Jimmy Kimmel Live) to attend separate Flat Earth conferences for the sole purpose of making hit pieces against Flat Earth.

These statements are false and made with a reckless disregard for the truth. Therefore, my clients DEMAND that you immediately:

- 1. Cease and desist from making any further false, defamatory or misleading statements about my clients, whether on your channel, during interviews on other peoples' channels, in print, audio or memes, including any tongue in cheek or veiled statements on any platform, both written or recorded, alluding to my clients involvement with illegal activities, or receiving goods or money from authorities in exchange for leaving the Flat Earth Community.
- 2. Remove all online content, transcripts, written posts and recordings of the false, defamatory or misleading statements from all platforms where they have been posted or shared;
- 3. Issue a public retraction on the same forums where the false, defamatory or misleading statements were made and acknowledge that the statements that were made about my clients are false. In addition, my clients require that you leave the public retraction posted on the forums.

Therefore, if you fail to comply with this Demand within seven (7) days of receiving this letter, my clients will have no choice but to consider all available legal remedies, including but not limited to:

- Filing a defamation lawsuit seeking damages for reputational and financial harm, including a potential claim for punitive damages due to the intentional, wanton, false, and reckless nature of your statements; and
- Seeking a court order compelling the removal of all false, defamatory or misleading statements.

This letter is the only written notice that you will receive to seek an amicable resolution of this matter.
